8. That I wish to be notified if the final decree of adoption is set aside or vacated so that I may exercise my right to petition the Court for a return of custody and custody shall be returned if the Court finds that it is in the Child's best interest to be returned to me.
9. That I do not intent to waive any of my rights under the Cheyenne River Sioux Tribe Children's Code or under the Indian Child Welfare Act by signing this consent.
